The KRISS Brand ID Guide is developed to provide a guideline to KRISS staff, partners and affiliates to use the KRISS brand consistently and effectively in all types of media format.

The KRISS logo represents innovative firearms technologies that correspond with the requirements of 21st century law enforcement, military, and civilian shooters around the world. Therefore, it is vital that this reputation for quality is supported by a strong and constant brand identity. This can only be achieved by adhering to the guidelines established by KRISS.

Parts of this guideline may need to be updated over time and will be published accordingly.

KRISS Logo Standards

Use of the KRISS Logo

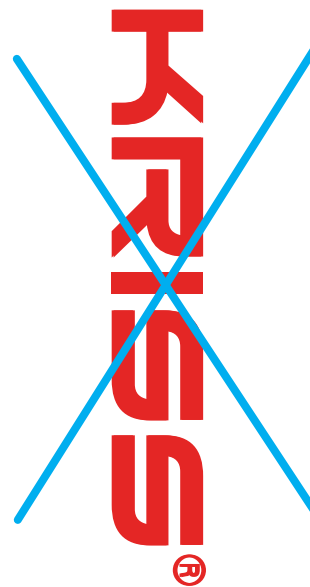
- ALWAYS use “original” KRISS logo artwork. Poor quality reproduction of the KRISS logo will reflect badly on the company’s image.



KRISS Logo Standards

Avoid Logo Format Alteration

- DO NOT alter or delete any part of the KRISS logo.
- DO NOT combine KRISS logo with other graphics, words or symbols.
- DO NOT display the KRISS logo vertically, diagonally or in an arc.
- DO NOT distort the KRISS logo.



KRISS Logo Clear Space & Size

KRISS Logo Minimum Clear Space

- ISOLATE the KRISS logo from other elements around it.
- The minimum clear space around the logo is the height of the logo. Allow more space when possible to make even greater impact.



KRISS Logo Minimum Size

- The minimum size for KRISS logo is 1" wide total width, excluding registration mark.
- Only use minimum logo size when layout space is extremely limited.
- Use larger logo size whenever possible.

KRISS Logo on color backgrounds

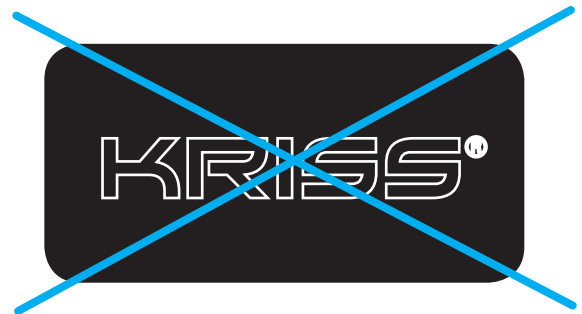
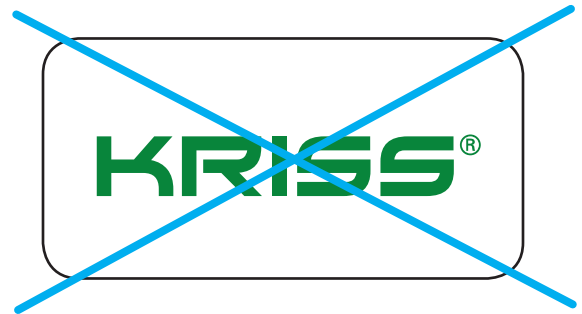
- KRISS logo should always be placed on a solid dark or light background with the previously stated minimum clear space.



KRISS Logo Color

KRISS Logo on textured or patterned backgrounds

- DO NOT place KRISS logo on a visually distracting or patterned background.
- DO NOT alter the color of the logo.
- DO NOT change the opacity of the KRISS logo.
- DO NOT change the outline of the KRISS logo.
